## **REPRESENTATIVE CASES:**

- Representative of Beijing Huayue Education Technology Co., Ltd. in dealing with a criminal investigation of pirated books, successfully seized a large number of pirated books and arrested the criminal suspects. The case was supervised by national ministries and commissions;
- Representative of Safe Skies LLC. in handling an arbitration case with a company in Dongguan, and successfully won more than 1 million yuan of liquidated damages.
- Representative of a well-known Japanese artist Takashi Murakami in the copyright infringement case and successfully obtained the compensation about RMB 1 million through non-litigation methods including investigation and negotiation;
